Sucroferric Oxyhydroxide Chewable Tablets

Background:

Hyperphosphatemia is a hallmark of advanced chronic kidney disease (CKD) and associated with adverse outcomes. It has been reported that 88% of dialysis patients are prescribed phosphate binders (Pbs). Several Phosphate Binders are currently available. Most PBs have a high daily pill burden, which may lead to poor adherence. Serum phosphorus levels and pill burden are inversely associated with adherence in patients on hemodialysis.

Description:

SUCROBIND contains Sucroferric Oxyhydroxide chewable tablet. Each chewable tablet contains 500 mg iron (equivalent to 2,500 mg Sucroferric Oxyhydroxide).

Indication:

SUCROBIND is a phosphate binder indicated for the control of serum phosphorus levels in patients with chronic kidney disease on dialysis.

Mechanism of Action:

In the aqueous environment of the GI tract, phosphate binding takes place by ligand exchange between hydroxyl groups and/or water in Sucroferric Oxyhydroxide and the phosphate in the diet. The bound phosphate is eliminated with feces.

Dosage:

The recommended starting dose of **SUCROBIND** is 3 tablets (1,500 mg) per day, administered as 1 tablet (500 mg) 3 times daily with meals.

USPs:

- Phosphorus control with half the number of tablets of sevelamer (4 Tablets vs 8-10 Tablets a day)
- High phosphate-binding capacity across the pH range in the gastrointestinal (GI) tract (1.2 to 7.5)
- Higher Rate of Patient Adherence with reduced pill burden
- Highly Palatable – Available in Chocolate flavor
- Patients can choose the way they take **SUCROBIND**: break, crush, or chew
- Well tolerated, with a similar long-term tolerability profile to Sevelamer Carbonate
